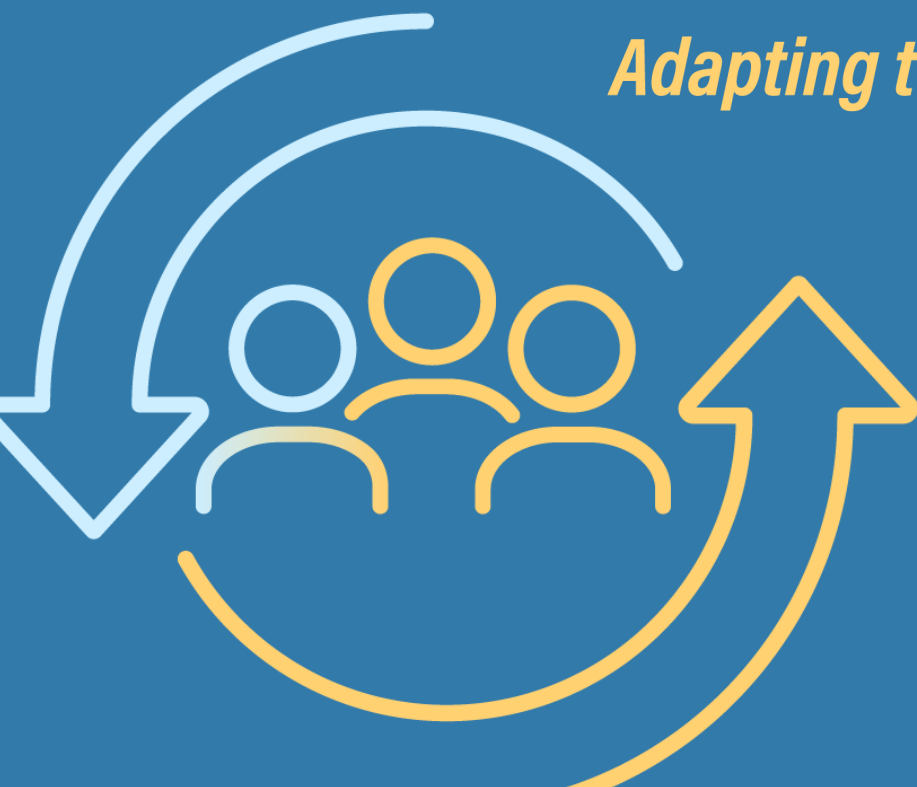

Barrett Adams-Simmons - Outreach Coordinator, DHS/Cybersecurity and Infrastructure Security Agency

Barrett Adams-Simmons is the Stakeholder Engagement Branch Chief for the Department of Homeland Security's Cybersecurity and Infrastructure Security Agency (CISA) in Region 10 (Alaska, Idaho, Oregon, and Washington) based out of Seattle, WA. In support of the Department's regional service delivery model, she works actively with critical infrastructure owner and operators and State, Local, Tribal and Territorial entities, to bring actionable resources and mitigation efforts. Before heading to the regional office, she was a DHS Senior Policy Advisor for Cybersecurity and Counterterrorism Policy working issues ranging from advanced persistent threats, encryption, responsible vulnerability disclosure, and positioning, navigation and timing. She also serves as the co-chair to the Control Systems Working Group's Supply Chain sub-Group to develop the implementation plan for the National Industrial Control System Strategy. Ms. Adams-Simmons was the lead Energy Security Advisor to the Assistant Secretary of Defense for Homeland Defense and developed long-term energy assured programs for the Department of Defense's most critical assets and specialized in Critical Infrastructure Protection and risk management. After graduating from the United States Naval Academy, she served as a Surface Warfare Officer on an Aegis Cruiser and Amphibious ship before taking her first policy position in the Pentagon with the Office of the Chief of Naval Operations Staff.

Before joining WaTech, he previously served as the Deputy Chief Information Security Officer for the state of South Carolina and also held several security roles for the state of New Hampshire Health and Human Services, including serving as the agency's CISO from 2015-2016. Kevin has been with the Washington State Patrol (WSP) since 1993. He spent the first 18 years in Communications (dispatch) in our Yakima, Wenatchee, and Vancouver Communications Centers. In 2011, Kevin was promoted to a position in our Information Technology Division at our help desk, supporting both internal and external users of WSP systems. After 2 years, he

promoted to the supervisor of the Tier 2 Customer Service Unit where I gained experience with IT Security, project management, and IT procurement. In 2016, Kevin was promoted to his current position, the CJIS Information Security Officer. As the CJIS ISO, he is the security point of contact in our state for the Federal Bureau of Investigation (FBI) CJIS Division, ensuring that CJIS Security Policy standards are implemented and maintained to protect Criminal Justice Information (CJI). He answer questions and provide guidance to agencies in Washington State regarding policy implementation for CJI or CJIS systems, as well as conducting technical security audits of criminal justice and non-criminal justice agencies to ensure compliance with CJIS standards. Kevin is also responsible for supervising the daily operations of the A Central Computerized Enforcement Service System (ACCESS) training and audit unit, a part of the WSP Criminal Records Division. ACCESS is a telecommunication system used by 500+ criminal and non-criminal justice agencies and 25000+ personnel in our state to obtain criminal justice information such as criminal history, driver and vehicle information, stolen vehicles, and wanted persons.

Local governments should be aware of the state's data breach notification law expansion. This presentation covers updates to RCW 42.56.590 that took effect March 1, 2020. The new law expands requirements on what type of data triggers data breach notification and shortens the amount of time that government has to respond. In addition, the new law includes additional reporting requirements to the state Attorney General Office. Learn the expanded definition of personal information, discover how to identify a breach and notification requirements, and discuss potential issues with implementation.

Katy Ruckle - State of Washington Chief Privacy Officer, WaTech

Katy Ruckle started in the role of Washington's Chief Privacy Officer on January 1, 2020. Before joining WaTech, she served as the Privacy Officer and Information Governance Administrator at the Department of Social and Health Services (DSHS) where she was responsible for establishing privacy practices for five administrations, including three hospitals, covering 16,000 employees. Katy developed and implemented the privacy program from its infancy to include 18 privacy coordinators across DSHS. In the course of six years running the privacy program she handled several data breach incidents which included federal investigations and media attention. Her leadership role at DSHS also included overseeing public records, records management, discovery, and HIPAA compliance. Before becoming the Privacy Officer for DSHS, she served as Contracts Counsel and worked extensively on Business Associate Agreements and other complex contract and procurement issues. Katy was born and raised in Washington, graduated from Western Washington University and earned her law degree from Willamette University College of Law. She was admitted to the Washington State Bar Association in 2005 and is a licensed attorney. She began her career with the state in 2006.
